**Beneficial Ownership of Applicant**

The following three entities have agreed to participate in 6934242 CANADA LIMITED (the "Applicant"), each with an ownership interest of greater than 10 percent:

- (a) Manitoba Telecom Services Inc. ("MTS");
- (b) CPPIB Private Holdings Inc.; and
- (c) Blackstone Management Associates (Cayman) V L.P. on behalf of six related funds.

There are no other individuals or entities that hold an ownership interest in the Applicant's voting shares, non-voting shares or other beneficial interests.

MTS is a publicly traded company and is listed on the Toronto Stock Exchange. No one individual or entity holds a greater than 10 percent beneficial ownership interest in MTS.

CPPIB Private Holdings Inc. is a wholly owned subsidiary of the Canada Pension Plan Investment Board (the "Board"). The Board is a federal Crown corporation established pursuant to the *Canadian Pension Plan Investment Board Act*. All of the shares of the Board are held by the Minister of Finance on behalf of Her Majesty in right of Canada. The Board is a fiduciary that acts on behalf of the 17 million contributors and beneficiaries of the Canada Pension Plan.

Blackstone Management Associates (Cayman) V L.P. is a part of the Blackstone Group L.P., a global alternative asset management group that is traded on the New York Stock Exchange. Blackstone's investment in the Applicant has been made on behalf of the

following six related funds. For each, beneficial ownership of greater than 10 percent is noted.
