





Qualification

The geographical indication is protected under "Commission Regulation (EC) No 1107/96 of 12 June 1996 on the registration of geographical indications and designations of origin under the procedure laid down in Article 17 of Council Regulation (EEC) No 2081/92". The organoleptic, physical and chemical characteristics of the "Majorcan Sausage" are related to the natural environment, as well as to the procedures of the elaboration and curing. The elaboration consists in the process of transformation of the meats, addition of paprika, salt and spices, in sausage. It consists of a first stage of preparation, properly speaking of the sausage, and a second phase of curing, in the course of which the sausage develops in its organoleptic characteristics due to biochemical processes that determine the traditional quality of this product and its characteristic flavor and aroma. The climatic conditions of the Island of Majorca, especially the influence of temperature and humidity, are not favorable for preservation of meat by curing the whole pieces; this means that the conservation has to be done by making cured raw sausages. One of the most remarkable peculiarities are the different intestinal tracts used for stuffing that determine the morphological variety of the sausage and the peculiar denomination of the sausage stuffed in them, thus the stuffed in blind intestine of pig denominates "Poltru" or "Sepultruu", in the large intestine: "Rissada", in the rectum: "Culana", in the urinary bladder: "Bufeta" and stomach: "Bisbe". The protected sausage, attending to the race of the pig, differentiate two types: "Majorcan Sausage" elaborated with pork meats of all the races and "Majorcan Sausage of black pig"

elaborated with pork meats of autochthonous Majorcan race, breeded and fattened on the island of Mallorca according to traditional practices, in extensive or semi-extensive regime. The sausages at the end of the curing process will present the following characteristics: Shape: irregular cylindrical, determined by the morphology of the gut. External appearance: the surface of the sausage will be dark red, smooth or slightly rough, with absence of mold or whitish mold. Paste: soft, not pliant, sticky, compacted, greasy, not very fibrous and with a red marble aspect. Flavor and characteristic aroma, with clear perception of the presence of paprika.
