The Examiner has indicated that *Carvings made by Inuit of Canada, principally in stone* is improperly classed under Nice class 20 with the proper class falling under Nice class 19.

We respectfully request that the goods under classes 19 and 20 now be classed as follows:

Class 19

Carvings made by Inuit of Canada, principally in stone.

Class 20

Carvings made by Inuit of Canada, principally in ivory, but also in wood, bone and antlers.

We note there was no objection in relation to classes 21, 24, 25 and 28.

We look forward to receiving acceptance of the classification of the goods as requested. We also note additional renewal class fees will be required.
