CONFIRMATION OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

- A. WHEREAS Maple Leaf Sports & Entertainment Partnership (an "Obligor") is the owner of: (a) the trademarks set forth in Exhibit A, the registrations and applications for the trademarks identified therein and the underlying goodwill associated with the foregoing as well as all the goodwill of the business connected to and symbolized by the such trademarks, (collectively, the "Trademarks"); and (ii) the copyright applications and registrations set forth in Exhibit A (collectively, the "Copyrights" and, together with the Copyrights and the Trademarks, the "Intellectual Property").
- B. WHEREAS the Obligor entered into general security agreement dated as of June 28, 2013 with Computershare Trust Company of Canada (the "Collateral Agent") as amended modified supplemented or restated from time to time (the "Security Agreement") under which the Obligor granted to the Collateral Agent security interest in certain property, including the Intellectual Property, as security for the obligations described therein.
- C. WHEREAS Computershare Trust Company of Canada entered into an assignment, resignation and appointment of agent agreement dated June 29, 2023 (the "Collateral Agent Succession Agreement") with among others, The Bank of Nova Scotia (the "New Collateral Agent"), pursuant to which: (a) Computershare Trust Company of Canada resigned as collateral agent for the Security Agreement and assigned all of its rights, powers, privileges and duties under the Security Agreement to the New Collateral Agent; and (b) the New Collateral Agent was appointed as collateral agent for the Security Agreement and expressly assumed the rights, powers, privileges and duties thereunder.

NOW, THEREFORE, in consideration of the premises and mutual covenants herein contained and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and in accordance with the terms and obligations set forth in the Security Agreement and the Collateral Agent Succession Agreement, the Obligor confirms the grant to the New Collateral Agent under the Security Agreement and the Collateral Agent Succession Agreement of a security interest in and to the Intellectual Property.
